Subject Fall 2021 Program Advisory Minutes

Discussion

The Fall 2021 Automotive Collision PAC Minutes were reviewed and approved by the committee.

<u>Subject</u> Program Updates (enrollment, competency attainment, curriculum, equipment & projects/field work, senior portfolio showcase, etc)

Discussion

Student enrollment has greatly increased over the last couple of years. Due to the addition of the after dark program and very strong freshman enrollment. We currently have 16 freshmen, 6 sophomores, 8 juniors, and 3 seniors enrolled full time as well as 2 juniors and 7 seniors in the after dark program.

The I-CAR curriculum is still being implemented with all juniors earning their I-CAR Non-Structural Pro-Level 1 certification and all seniors earning their I-CAR Refinishing Pro-Level 1 certification.

Thanks to a very generous private grant the school was able to purchase a new Miller Silicon Bronze welder which the committee has previously recommended to keep up with technology changes in the collision industry.

The committee reviewed all of the customer work requests which were completed by the students this year. The committee felt that they all had very good educational value and that the repairs were completed to industry standards.

The committee was informed of the portfolio review process and the date on which the portfolio presentations will take place. We are hoping a few members can attend if their schedule permits.



<u>Subject</u> Cooperative Education Update

Discussion

We currently have three students in the cooperative education program. We have a senior who is employed at Jiffy Lube in Beverly, one Junior who is employed at Danvers Ford in Danvers and another junior employed at Precision Autobody in Gloucester. We also have an after dark student in the process to be employed at IRA Collision Center in Danvers.
